Session Overview

The Greenhouse Gas Reduction Fund (GGRF) is a \$27 billion investment to mobilize capital to address the climate crisis, especially in communities that have historically been left behind. Despite this and myriad other new federal and state funding opportunities, many urban and rural American communities are struggling to access the capital, capacity, and talent required to build critical community infrastructure projects. This session provides an overview of best practices for approaching GGRF lending opportunities in 2024. The session also provides an overview of the Milken Institute's 10,000 Communities Initiative, which aims to ensure that cross-sectoral attention, federal technical assistance funding, and impact capital are effectively deployed to the underserved communities that need it most while supporting project developers with advancing qualified climate infrastructure projects.

Session Outcomes

Session attendees will come out of this session with a clearer sense of what the GGRF program may catalyze for developers, CDFIs, and communities with climate infrastructure projects in their pipeline. Attendees will be better able to navigate the structure, timeline, and eligibility requirements of GGRF financing. They will feel more prepared to identify projects appropriate for GGRF resources and proactively approach lending institutions to start building critical relationships. They will gain an understanding of the crucial project predevelopment steps they need to accomplish before formally seeking GGRF and other lending opportunities and gain



insight into the expectations lenders will have when they conduct due diligence on a project loan application.
